## The Problem

Schools and clinical sites share a heavy burden when attempting to facilitate internships, clinical rotations, and other opportunities for students. Typically, clinical sites like hospitals or doctor's offices vet staff via employment background checks—but student clinicians don't go through those traditional hiring processes.

Instead, schools typically take on the administrative burden of tracking students' immunization and health records. Clinical sites may also require drug testing and criminal background checks, with the burden falling on either the site or school.

Schools obviously want students to receive the required screening so they can be matched with appropriate clinical opportunities. Students may not understand the urgency of these processes, leading to delays that benefit no one.

Even when students are motivated and complete their tasks quickly, schools must submit information to different clinical sites, and those sites must review results to make decisions about each student. Student screening can be complex and cumbersome, especially for sites using manual processes.

## Background

Clinical placements can account for [up to a third of a student's time](#), making them critically important for ongoing education and creating a foundation for success in a person's career.

One challenge in this process is that clinical placements are not unlimited, and program administrators often face issues in securing enough slots to support their students. When opportunities are limited, every detail counts. Missing information or slow screening processes can cause a student to lose their placement to another applicant.

Another challenge is that the background check the school runs should align with the requirements of the clinical site, including expert review to ensure compliance. When these requirements are not met, the school is at risk of losing a contract with a clinical partner, which in turn could force a reduction in admissions and cause reputational damage.

In a review of the literature regarding [challenges in nursing education](#), clinical students named a lack of sufficient organizational support as a top issue. Regarding screening processes, students may not have access to intuitive options for completing screening tasks or might feel that administrators don't communicate well regarding such needs.

Student engagement with the process can also be a challenge. Almost three-quarters of students in these settings are “[post-traditional](#),” which means they may be [older than 24](#), single caregivers, employed full-time, or have dependents. Post-traditional students typically have numerous obligations outside of school, causing them to split their time and other resources accordingly.

While post-traditional students often bring maturity, life experience, and high levels of motivation to their clinical education work, they may be less likely to complete tasks that seem routine or mundane. If they don't see why a task is necessary, they may decide it's not worth their time—this puts an additional burden on school administrators to ensure students understand the importance of screening tasks.

## The Solution

### *Criminal Background Checks*

StudentCheck supports criminal background checks that include:

- Up to 7 years of county criminal records
- Up to 7 years of state criminal records
- National Sexual Offender Registry information
- SanctionCheck exclusion screening
- An SSN trace and SSN Death Index search
- And more

Each school is able to add additional searches, as needed.

This level of criminal background check helps organizations know clinical students are who they say they are. It also ensures that no clinical student has a criminal background that might exclude them from the opportunity or create compliance risks for your organization.



### *Drug Testing*

Drug testing includes:

- Customizable drug panels
- Partnership with more than 10,000 collection sites
- Electronic Chain of Custody
- Medical review officer (MRO) to review test results when necessary

Results appear in the StudentCheck portal. Because students can log in and see their results, they don't have to contact schools or clinical sites to find out whether they passed drug testing, cutting down on potential work for staff.



### *Immunization Tracking*

Immunization tracking features include:

- All records reviewed by a healthcare professional
- On-demand reporting system
- Customizable compliance reporting

Immunization information appears in the StudentCheck portal, and schools can also customize email alerts for certain document requirements to help accelerate completion of the screening process. Email alerts put students in control of their immunization tracking, increasing the likelihood that motivated students will quickly address missing documents.
